Roster Duties

On the Tuesday preceding your roster appearance, the duty officer should contact one of the listed volunteers as a reminder, and to pass on the phone number of the other person. You can then arrange a time to take the tanker for a spin; visit the nominated hydrant and check for workability (and red-backs and snakes, etc.).

On return to station, write a note in the vehicle log book. Please leave a note of any problems encountered. (Like the Hydrants that cannot be found!)

Pager Alerts via SMS messaging

Our brigade has been allocated eight slots for members who would prefer to receive Alert messages via SMS instead of carrying the separate (and additional) pager. If you wish to change from Pager to SMS all you need is your mobile phone. If you return your Pager, then we can allocate it to another member.

Fire Season Briefing

I trust you have all received and Digested the CFA Pre-Season Update and digested the fine print.

Of special note is marking of burned trees with a yellow K to indicate that it will likely fall or drop branches and needs to be kept clear of. The other snippet that Authorities are keen on pursuing is fires of suspicious origin. We're too busy assessing the fire as we approach, but we need to take note of vehicles in the area and people on the fire-ground – they may be fighting the fire; but they might be stoking it!

Fire Hydrants

The last thing you want to have to search for during an emergency is a Fire-plug. Some of our Hydrant markers are getting past their use-by date and we're preparing a list of defects to send to whomever is supposed to be looking after Hydrants.

Tall Grass and Fire Restrictions

While this damp weather keeps up, the start of fire restrictions will be delayed. But the dry land curing of the grass is advancing toward the danger threshold of 70% (in spite of the official figure at Sale being 20%). On a windy day, a fire can still travel through long grass in spite of new growth at ground level. Keep up the efforts to slash grass or convince a herbivore to eat it.

Back Page

Due to recent issues on the rail trail, the Gippsland Plains Rail Committee of management would like to make the local community aware of our obligations managing Crown Land. While we have volunteered our time and effort for almost twenty years, there are still some people who continue to break the law and have caused damage to the trail asset. Motorised vehicles are continuing to dig up the trail surface and deposit mud across the Rainbow Creek Bridge, illegal building waste dumped on the trail which has been sorted out by the appropriate authorities, and fences being pulled down on the Rainbow Creek chicane. As the trail progressively is constructed and more people use it, these matters are brought to the committee's attention and as we don't have the resources at hand to deal with them, in the future we will call on the authorities to administer the law for those who insist on breaking it.

While the Committee of Management continues to move ahead and negotiate with the community on trail development issues, we will leave those with the legal power to deal with offenders. If you have broken the law or intend to continue to cause damage to the trail assets, then expect that you will be prosecuted.

On a happier note, we have constructed the chicanes at the top of the trail at Cowwarr on both sides of the road and will continue with the chicanes at Afflecks Road intersection in the next few weeks. This means not having to stop and open gates which has been a concern for local trail users. -it also means wandering animals will escape so the adjacent landholders with poor fencing please be aware.

And we do have a Coalition Government pledge of \$800,000 to assist with the replacement of bridges over the Latrobe River Floodplains which is terrific. We are currently working through that issue and expect some good results in the new year. Finally we are relying on the community to continue to report any illegal activity on the trail to the authorities. Due to the length and demographics of the trail, we cannot check daily on every section and do appreciate those who keep us informed of issues arising. We thank you sincerely for your efforts.
